

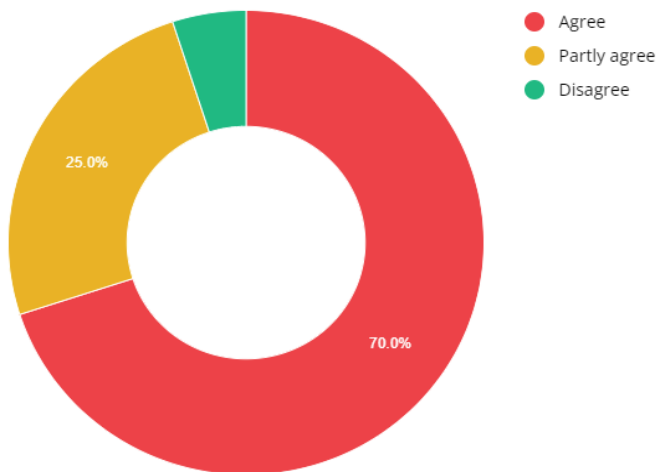


Dear Parents and Carers,

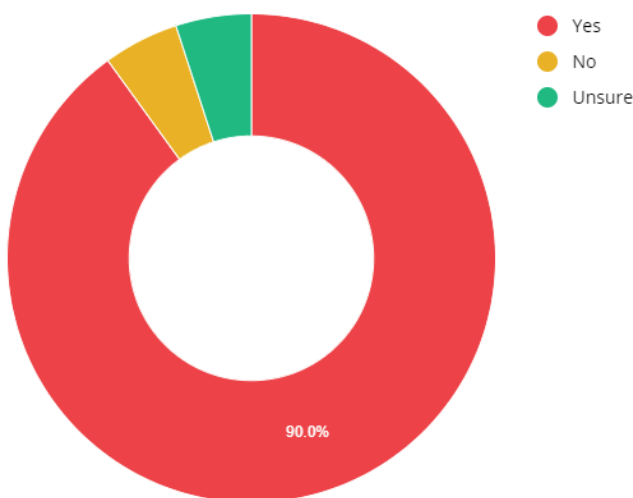

Parent/Carer Feedback: We feel very enthusiastic with regards to what the new year will bring for our child, now we're all in a better position to understand how best to support her achieve her potential. The new plans and strategies feel relevant, appropriate and personalised and we can tell that our child is already feeling the benefit of some of the practical adjustments and the inclusive approaches. 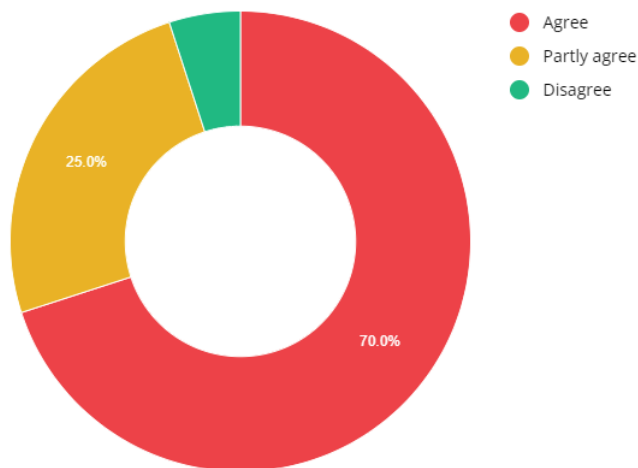

Parent/Carer Feedback: I'd prefer it if I had more frequent updates regarding my child's needs.

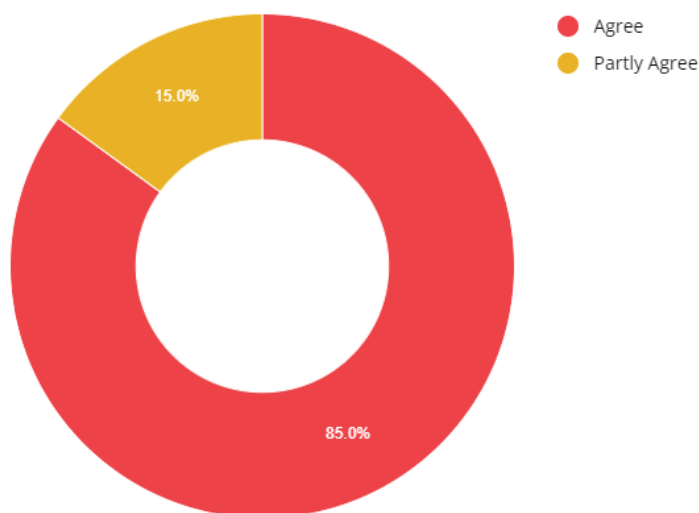

Parent/Carer Feedback: Always grateful and appreciative of all the extra support my child is given, many thanks.

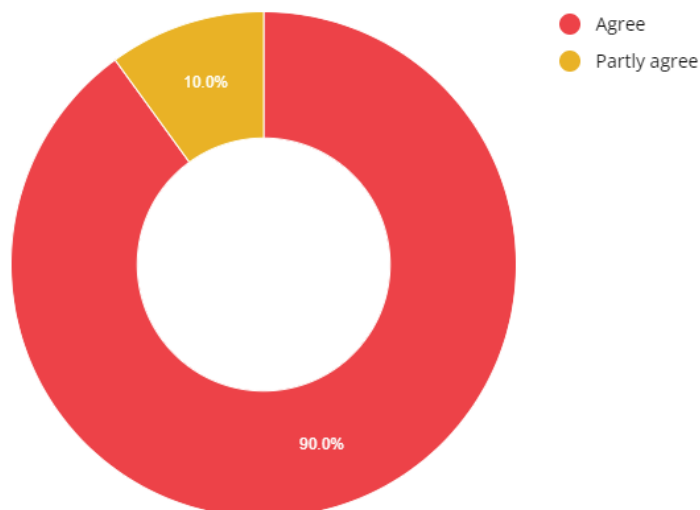
I feel that I have sufficient information and communication about my child's progress

School response:

Thank you for your feedback, We have carefully considered your responses and have made the following updates to our provision/calendar:

At the start of each Academic Year, **new class teachers** will aim to meet with parents and carers within the first two weeks of term. This early conversation with support a swift transition for your child into a new class and provide our parents and carers with an early opportunity to ask questions and provide any updates.

IEP review meetings will continue to take place on a half termly basis.

IEP review meetings will continue to provide an opportunity to explore what is working well and next steps.

As part of our graduated response to children's needs, we can determine if additional assessments are required in order to understand your child's needs in greater depth.

Homework: Our class teachers will work with you, our parents and carers, to develop a personalised approach to homework, that will support our children to access to learning enrichment.

This may include:

- Access to tutoring/homework support
- Personalised homework
- Identifying priorities within the homework set to avoid cognitive overload.
- Signposting parents and carers to resources and additional support materials.
- Providing bespoke modelled videos.

Introduction of a SENDCO DROP IN:

Each Term, our SENDCO, Mrs Kate Hobson, will lead a Parent and Carers SEND drop in. This will be the opportunity for parents and carers to ask any specific questions around your child's needs, assessment or diagnosis of a specific learning need.
